## LINDELL W. STURGIS MEMORIAL PUBLIC SERVICE AWARD

The family of the late Lindell W. Sturgis, former member and chairman of the SIUC Board of Trustees, established an endowed fund in 1979 to support recognition of public service efforts by SIUC faculty and staff. The Lindell W. Sturgis Memorial Public Service Award is presented annually to a current employee as recognition of his/her contributions to the community, area, state, or nation, based upon activities unrelated to job responsibilities.

### **AWARD**

This prestigious award, including a cash gift of \$750, a plaque and reserved parking space for a year will be presented by the SIUC Board of Trustees at the February 2010 Board meeting with a special luncheon to follow.

### **SELECTION CRITERIA**

- Nominee must be a current faculty or staff of SIUC at the time of nomination.
- Nominee's service to their community, area, state, or nation should be unrelated to their University responsibilities.
- Nominee's contribution/role must have positive impact or have fostered awareness in those areas they serve.
- Nominee should have committed substantial time to service.

### **NOMINATION PROCESS**

- Nominator may be an SIUC employee OR a member of the general public.
- Nominator should provide a clear statement (two-page maximum) of the candidate's contribution(s) as it relates to the selection criteria.
- Nominator should provide two - three letters of support.
- All public service contributions should be listed in the appropriate section of nomination form.
- Nominator should provide supporting documentation of public service contribution to include time devoted and examples of positive impact.
- Individuals who were nominated previously, but not selected, are eligible for re-nomination. It is preferred that a new application be submitted.
- Nomination Deadline: no later than **January 8, 2010**.
